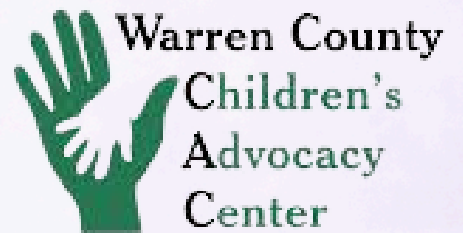

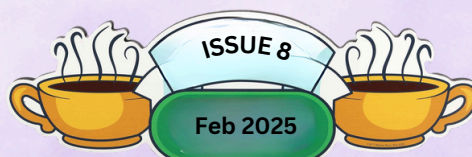

NOMINATION FOR STATE OFFICER

If you have an Auxiliary Sister that would like to become a State Officer, please send a letter of recommendation stating her qualifications. A motion must be made at an Auxiliary meeting. It must have a second and must be carried by majority vote. The letter must be signed by the Madam President and the Madam Secretary over the SEAL of the Auxiliary. If the candidate is one of the above Officers the Vice President or one of the Trustees may sign the letter. The office of the Madam Outside Guard is filled by Nomination from the floor and must be accompanied by a nominating speech of no less than two (2) minutes and no more than five (5) minutes. The speech shall consist of qualifications and capabilities of the nominee. A delegate, PMP or a Ten- Year Secretary shall give the nominating speech. Members are not permitted to nominate from the floor. Letters should be sent to the PA. State Auxiliary Secretary.

To office of the Madam State Vice President and the Madam State President in the State Auxiliary the candidate must hold the rank of Past Madam President and/or ten-year Secretary and such candidate must be in good standing in her local auxiliary.

To be eligible for any other office in this State Auxiliary a candidate must have been an Officer for five (5) consecutive years in her local Auxiliary and such candidate must be in good standing in her local Auxiliary.

ELIGIBILITY REQUIREMENTS FOR INDUCTEES TO THE HALL OF FAME

1. Any Sister who has shown outstanding and exceptional devotion and loyalty by serving above and beyond what would be expected by this Sisterhood at the Local, District, or State level.

5. Letters of recommendation must be in the hands of the Hall of Fame Chairman by the deadline date.
6. The deadline date will be published along with these guidelines in the Pennsylvania State Auxiliary bulletin.

6. 10 POINTS District scrapbook must contain one page with material from each auxiliary. (If pictures of Aerie officers are unavailable there will be nothing taken from these points.)
7. 5 POINTS Correct word spelling
8. 5 POINTS Picture of District or Auxiliary Mother and Caption
